## VIOLENCE AGAINST WOMEN ACT (VAWA) PROTECTIONS

- Established in 1994
- Three large provisions:
  - Ability to Self-Petition if one is married to an abusive U.S. Citizen or Lawful Permanent Resident.
  - Ability to file for waiver of joint-filing requirement in a marriage-based removal of conditions case
  - VAWA Cancellation of Removal relief for individuals in removal proceedings.

## SPECIAL IMMIGRANT JUVENILE STATUS (SIJS)

#### First File with a State Family Court

- Under 21, Living in the United States
- Not Married
- Juvenile Court Order finding:
  - Dependent on the Court
  - Court Order Special Findings: Child cannot be reunified with one or both of their parents because Abuse, Abandonment, Neglect, or a similar basis under state law; AND
  - It is not in their best interests to return to the country of nationality or origin.

#### Then File Self-Petition with USCIS

- Under 21, Living in the United States
- Not Married
- Juvenile Court Order finding:
  - Dependent on the Court
  - Court Order Special Findings: Child cannot be reunified with one or both of their parents because Abuse, Abandonment, Neglect, or a similar basis under state law; AND
  - It is not in their best interests to return to the country of nationality or origin.

## U NONIMMIGRANT STATUS: "U-VISAS"

"Congress makes the following findings: Immigrant women and children are often targeted to be victims of crimes committed against them in the United States.....All women and children who are victims of these crimes committed against them in the United States must be able to report these crimes to law enforcement and fully participate in the investigation of the crimes committed against them and the prosecution of the perpetrators of such crimes."

## T-NONIMMIGRANT STATUS: "T-VISAS"

- Victims of Trafficking and Violence Protection Act 2000.
- Survivors of severe forms of human trafficking.
- Human trafficking is a form of modern-day slavery in which traffickers use force, fraud, or coercion to compel individuals to provide labor or services, including commercial sex.

## ASYLUM, WITHHOLDING OF REMOVAL, PROTECTION UNDER U.N. CONVENTION AGAINST TORTURE (CAT)

<ul><li>Afraid to return to home country due to</li></ul>
☐ Past persecution or
"'Well-founded" fear of persecution upon return
Persecution must be "on account of":
□Race
□Religion
□Nationality
☐Political opinion
☐Membership in a particular social group

## CHANGES TO ASYLUM

Matter of AB – attempt to role back protections enshrined in international and domestic law

Private actor violence (gang violence, domestic violence) should generally not qualify for asylum

### **BORDER POLICIES**

## How Process Should Work:

- Asylum seeker arrives at POE & expresses fear to CBP officer
- CBP performs initial screening, then refers case to regional asylum office;
- Asylum officer performs CFI; if positive finding, bonded out/paroled and released from detention (family together, work while waiting, obtain counsel)

## **Current Reality:**

- "la lista" wait in MX weeks for "number" to be called
- "'la hielera"
- Children separated from parents
- Detention during entire process (abusive conditions)
- Application of Matter of AB in immigration court

## CHALLENGES TO CURRENT POLICY

- Grace v. Whitaker: Injunction issued by District Court judge prohibiting application of certain provisions from Matter of AB to CFI proceedings
- 04/08/2019 SF District Court Judge issues preliminary injunction enjoining Migrant Protection Protocol policy



## CHANGES TO OTHER SURVIVOR BASED APPLICATIONS

- FEE WAIVER DENIALS
- DOJ FUNDING CUTS TO ORGANIZATIONS WORKING WITH SURVIVORS
- GENERAL CHILLING EFFECT OF INCREASED ENFORCEMENT AND OTHER POLICIES
