I'm proud of the fact that we've been able to cope, and still offer meaningful and relevant mission-based programming.

I know in my branch we are struggling to resume even small in- person events. There are just too many younger grands and greatgrands whose health we have to protect. And most of us seem to have someone in our lives who's either older or has a compromising health condition that makes it just too scary to get together inside. 

The September 2021 meeting of the State Board was held on Thursday, September 9th. The Board agreed to hold the meeting a week early because Mary has pressing family business the week the meeting would normally be held. Here's what we decided:

- ♣ We approved the Minutes of the meeting held on August 19, 2021, as submitted.
- Kyle will be providing the Financial Report via e-mail because there had not been enough time to prepare them after receipt of the bank statement due to the revised meeting date.
- ➡ Mary said she thinks the branch presidents find the monthly zoom meetings to be helpful so they will continue. Presidents have the option of attending a 10:30 a.m. or 7:00 p.m. meeting on the last Monday of the month.

- Mary will be serving on the National Advancement Committee.
- Sandra reported that nine individuals have signed up for Bill Track 50 and three branches have begun using it.
- Yvonne Berliner is the Director for Diversity, Equity, and Inclusion (DEI). In this role she is a member of the National DEI Committee. She is looking for speakers who are knowledgeable about the disappearance and murders of indigenous women. If you know of people who are experts in this area, please let her know. She is hoping to find speakers who would work with branches on mission-based programming.
- ♣ Branches are encouraged to use the YouTube recordings from the webinars, but we need to make sure we have revenue and participation from members who actually attend the event. Several branches have asked us to provide them the recordings with a copyright waiver. The board agreed that a reasonable fee is the cost of attendance of 10% of actual branch membership as of the date of the webinar with credit for those members actually registered.

Public Policy Leader Resource Manual and the Importance of Gender Equity Positions of Local Candidates

I just received the 2021-2022 Policy Leader Resource Manual! It is 44 pages long and full of great information, it includes a section Candidate Endorsements [click to view/download from website...] The key takeaway is if your Branch wants to endorse a nonpartisan local candidate you must 1) focus on AAUW issues positions 2) interview or research equally all candidates and 3) make your process objective and transparent. AAUW encourages States and Branches to get involved in local policymaking to ensure gender equity is included in policies not only by governors and legislators but also by mayors and city council members and school board directors. See Kate Nielson's statement: https://www.aauw.org/act/state/

Why is gender equity advocacy so important at a local level?

The Texas Abortion Ban Law is a good example. The law was first adopted as an ordinance in a small Texan town (population 1600) that had no abortion clinics or providers. Dozens of other Texan mayors and their city council members adopted the same ordinance, including Lubbock that had a Planned Parenthood Clinic (which closed). What do you know about your mayor and city council members positions on reproductive health care rights? Would they support an abortion ban ordinance? Do they support and practice equal pay? Sexual harassment and domestic violence protections?

School Board Directors also have a powerful influence on gender and racial equity in education. We have seen this in school board responses to comprehensive sexual health education and the equity training. Some school boards have stepped up for gender equity. The Chehalis School District passed a gender equity policy that "aims to better socially integrate transgender and "gender-expansive" students." Editor's Note: The following section contains a series of articles on Tech Trek. The first is a report on this year's virtual camp. The remainder describes various aspects of the program and what needs to be done to make the camps happen.

A Successful 2021 Camp Year

What a wild and crazy year for Year 9 of Tech Trek WA (not counting 2020 – another wild and crazy year). All things considered our 2021 virtual Tech Trek WA camp was a resounding success! We had one week of virtual STEM learning for girls from throughout Washington that combined the PLU and EWU 2020 and 2021 selectees. We had originally anticipated having about 130 campers but ended up with 88 signing on to attend the virtual event; 2020 campers were given the option of attending the virtual camp or not. About half of those selected in 2020 opted out of attending virtually.

Campers selected from five different core classes, held for three hours each morning – Bodies by Design (human body systems), Chemistry, Climate Change, Cybersecurity and Thinkabit Wearable Tech.

After hearing from a diverse group of professional women in STEM in "Inspiring Moments" after lunch, students attended two lab/workshop sessions in three afternoons. Everyone got to build a pinhole camera in the Eye See You workshop and each camper selected three additional lab/workshops to attend. With the pandemic so much in focus, former EWU Camp Director Kate Aultman provided a "Disease Detectives" workshop on epidemiology from her new home in Texas. Another new curriculum for Tech Trek was hydroponics, with Prof. Sandya Kesoju, from

Columbia Basin College, who did part of her presentation from the field when she was observing other experiments.

Campers spent Tuesday afternoon learning how to budget and live within their means in a Reality Fair, provided by Washington Financial Beginnings with volunteers from Bank of America, where each camper was assigned a career which came with a monthly salary. They were required to "purchase" such things as housing, transportation, food, leisure activities. Some had student or credit card debt. All were advised to budget for saving for unexpected expenses. It was a lively and fun afternoon.

Tech Trek WA engaged the services of Event Support to manage the many Zoom platforms needed. The Event Support team was critical to a most successful virtual year and campers were exposed to just one more example of women leaders in technology management.

How Tech Trek WA Operates

All branches in Washington are invited to participate in Tech Trek. Sixteen branches participated in the 2021 camp, including WA Online and Coeur d'Alene, Idaho. WA Online selected 2020 campers from areas of the state where there is no AAUW presence. Three of the five 2020 campers selected by WA Online, funded by state-raised funds, attended the 2021 camp.

The northern Idaho area does not have any college campuses with residential facilities, so it would be extremely difficult for branches like Coeur d'Alene to ever have a Tech Trek program. So, again this year, Idaho was invited to participate in the virtual 2021 camp. Three of the four campers selected in 2020 by Coeur d'Alene branch attended. The funds were generated by Coeur d'Alene branch, individual donations and AAUW Idaho.

Transitioning to Autonomy

After five years of piloting the Tech Trek program nationwide, AAUW turned the individual programs over to the AAUW entities (states or branches) in 2018 who have been implementing the program in their local areas. Tech Trek WA has always been and continues to be a project of AAUW-WA. AAUW WA Special Projects Fund is now the sole fiscal agent for Tech Trek WA. All donations should be made through AAUW-WA SPF. AAUW-WA SPF is recognized by the IRS as a 501(c)(3) charitable organization so any contributions made to AAUW-WA SPF on behalf of Tech Trek are fully deductible to the donor. Contact your branch Tech Trek coordinator for details on how to give or email techtrek@aauw-wa.org with questions. Funds designated to your local branch and given to AAUW-WA SPF go directly to support girls from YOUR branch. Truly, a win/win situation!

Branches Drive the Bus for Success

Branch support and participation have always been the backbone of the AAUW WA Tech Trek program and continues to be the principal driver to Tech Trek WA's success. Local AAUW branches identify, select and fund campers from their local area. All camper candidates are recommended by their STEM teachers; criteria include being a student highly interested in STEM subjects who otherwise would not likely attend a program like this.

Our team of successful fundraisers (Dorothy McBride, Rosette Dawson, Kelvie Comer and others) are available to answer any of your fundraising questions or help you with grant applications. A PowerPoint presentation is available that branches can use locally with potential funders, as well as an hour-long video summary of the closing session for the 2021 camp. These past nine years have been GREAT FUN and provided many, many moments of sheer delight to campers, their parents and all staff involved. We have heard from past campers how Tech Trek opened doors for some STEM idea or field of study to the absolute joy of launching a balloon and of course, there are the small and dramatic explosions! The staff and leadership have stayed alert to changing curricula to meet new interests and ever-evolving scientific knowledge and application.

This is YOUR direct invitation, to ALL AAUW MEMBERS and POTENTIAL MEMBERS, to become a part of the leadership team that steers the bus. There is always the need to plan for the future, add fresh ideas and, of course, there is a void to be filled with leaders willing to take smaller and larger jobs. Each of the stipend positions has a job description on the website under VOLUNTEERS. The vitality of camp is based on a steady diet of interested persons, the "get it done" attitude, and the willingness to try something new. The first planning meeting will occur during the first two weeks of November so please let someone know of your interest level. The fun is really contagious!

Between now and January 1st, the AAUW-WA Tech Trek website will be continually changing, as we add information on the 2022 camps and develop an INSPIRING WOMEN tab. We are currently planning for in-person camps for July 2022, two weeks at PLU (July 10-16 and July 17-23) and one week at EWU (July 24-30).
