President's Message

Earth Day began April 22, 1970; since then, it has become an environmental movement. It is now the largest civic event on earth with 192 countries participating or 1 billion people! There are so many associations, activities and projects that have joined together to save the planet.

I have been involved in a couple of activities myself and it certainly has made me more aware of the issues. One project was working with a group planting hemlock, cedar, and fir trees along the Green River that would eventually grow and make the river more habitable for salmon. It was hard work, digging a hole, mounding the dirt for the roots, and bringing in a tub-full of mulch four inches from the plant, surrounding it to protect the little tree from weeds. Another project with my church was packing little seedlings in special containers and caring for them for 2 years and then preparing them to be planted along streams, for salmon spawning habitat. A third project, also with my church, was giving up plastic for Lent. I discovered how much nonessential plastic I used and what kinds of plastic can be recycled. I also joined a company out of Oregon, called Ridwell, that picks up multilayer plastics (resealable food bags, potting soil bags, and chips bags) and plastic film (bubble wrap, bread bags, newspaper bags, and dry-cleaning bags) every two weeks. David Attenborough, in his book titled A Life on Our Planet, has a photo of all the plastic on Christmas Island beach, amazing. He also discusses sustainability, rewilding the ocean, forests, and land; his three P's for maintaining our world are a balance of people, planet and profit.

Another symbol of balance is the Gaia Hypothesis. Some years ago, I read a book on the Gaia Hypothesis by Carl Sagan's former wife Lynn Margulis an evolutionary

biologist, which proposed that the earth itself is a living being, a self-regulating, complex system whose goal is continual balance, homeostasis, and adaptation to support life on this planet. Though not well received originally by scientists, the concepts are now addressed and investigated in Earth system science. What I find most intriguing is that Gaia is a female Greek Goddess, the personification of the Earth, or Mother Earth. Maybe this sounds far-fetched, but I think we women can be proud of that fact that we are the symbol chosen for this theory, I have not been able to find out how this happened, but the idea of Mother Earth can be found in many ancient cultures, all of life and its elements flow through her. Therefore, as woman we can take ownership of the concept and participate in whatever aspect or activity that supports life on earth whether it is education, conservation, or legislation.




State News

Initiatives - At our next Public Policy team meeting on April 23^{rd,} we will review draft statements and one-pagers in support of a NO vote on three initiatives that will be on the ballot in November.

AAUW is nonpartisan, so while we do not endorse candidates, we can endorse bills, referendums and initiatives. For a quick review of the three initiatives see the WA Physicians for Social Responsibility webpage, it has nice graphics. Learn more <u>HERE</u>

- I-2109 would repeal the capital gains tax. Invest in WA is one of the key advocacy groups on the Vote NO on I-2109.
- 1-2117 would repeal the Climate Commitment Act. Check out the <u>Public Disclosure Commission's NO on 2117</u> contribution list. "Follow the money" is a good way to see who the key financial "stakeholders" and influencers are.
- I-2124 would "strip" the new WA Cares program of funding. Learn more about the WA Cares program <u>HERE</u>. Here is a one pager from the <u>NO on I-</u> 2124.

Living Wage -For our branches, the living wage ranged from a low of \$42,588 in Lewis County to a high of \$62,572 in King County for a single adult, no child.

Living Wage calculator - We have a new <u>Living Wage report</u> by County! We can add living wage and cost of living to our pay equity conversations. Check out our <u>Pay</u> Equity webpage.

The Living Wage calculator (MIT manages the data) includes:

- Minimum hourly living wage for 1) single adult household, two adult household (o=only one working and two adult household both working and with and without child).
- "Occupational Areas" with average wage.
- Cost of Living table.

Occupational Choice Matters -Many occupational areas do not provide a living wage and it varies depending on where you live.

- In King County 10 occupations out of 22 do not provide a living wage salary.
- In Snohomish County, 7 out of 22 occupations.
- In Lewis County, 3 out of 22 occupations.

See <u>Living Wage Salary and Occupational Options by Branch</u> to see which occupations do not provide a living wage in your county.

Cost of Living- Here is a snapshot of our Branch differences by cost of living:

- Housing costs differed by \$15,366: from a low of \$11,893 in Walla Walla to a high of \$27,259 in King County.
- Childcare differed by \$9,702: from a low of \$10,293 in Walla Walla to a high of \$19,995 in King County.
- Food cost differed by \$1,205: from a low of \$4,101 in Lewis County to a high of \$5,306 in Jefferson County.
- Transportation differed by \$2,032: from a low of \$8,932 in King County to a high of \$10,964 in Lewis County.



Voting on the "Open Up AAUW" initiative to eliminate the college degree requirement for AAUW membership is underway. If you've already voted, thank you! If you haven't yet voted, there is still a month in which to do so. By now, you should have received an initial ballot and, if you haven't already voted, at least one reminder e-mail that contains your Elector ID (AAUW member number) and your unique voting password. The proposed National bylaws changes are detailed on the AAUW website at AAUW National Election 2024, where you can also find an Open Membership Toolkit and FAQ. In addition, the Open Up AAUW website contains much information on this change.

The voting period closes at 9 am PDT on May 15th.

Bylaws Proposed Changes

At the Annual Business Meeting on Sunday, April 21st, we'll be voting on a set of proposed changes to our AAUW Washington State Bylaws. The Bylaws will be changed in two ways. The first is that the AAUW-mandated articles I through VII have been replaced in their entirety with the latest version provided by National after the spring 2023 approval vote of proposed changes by AAUW membership. There is no further vote on the mandated articles. The second is that the State Board is recommending some changes to the AAUW-WA unique articles – and those must be voted on by our membership. If you haven't yet taken a look, please review the proposed changes posted on our website, 2024 Proposed Bylaws Revisions, to prepare for the vote.
