# President's Message

As I read the 'end of the year' newsletters, listen to what the branch presidents say about their end of the year gatherings and participate in my own branch meeting, I hear lots of thanks, recognitions for service, and gratefulness for celebrating another successful year for AAUW -WA members.

A sincere thank you, identifying specific activities, goes a long way in building continued commitment to the mission and vision of individuals and the group. I do not necessarily think that we perform our activities just to receive praise, but gratitude often stimulates innovative ideas and creativity and a willingness to advance other projects and roles. Thanking someone or a group provides opportunities to feel included, supported, and worthy. It is powerful.

When I was completing a master's in nursing, my thesis was on the concept of loneliness, <u>A Critical Interpretation of the State of Loneliness</u>, and its Relevance to Nursing (1967). My review of the literature included everything I could find in psychiatry, psychology, theology-philosophy, literature (poetry), sociology and anthropology. One of my recommendations was to incorporate a question about loneliness as part of the client history and assessment to address the situation in the care plan. A few years later, I attended a seminar on relationships. One of the unexpected measures of health was having friends. I remember that the researcher stated, "Your mom was right, go outside and play with your friends." Now years later, the U.S. Surgeon General Dr. Vivek Murthy, has issued a report (05-02-23), "Our Epidemic of Loneliness and Isolation". He shares statistics about the increase in heart disease, stroke, and dementia as all indicators of the results of loneliness. He has six suggestions. The first one was: Strengthening social infrastructure, which includes things like parks and libraries as well as public programs. And the sixth one is: Cultivating a culture of connection.

I think that organizations and groups like AAUW can more intentionally recognize and support these two recommendations. People need to belong and be involved; it is good for the larger society and individuals. So be generous with thank you's and celebrate relationships. Stay connected!

There are many new features accessible to users of a Canva Pro account: extensive templates, creation of a "branding kit," QR codes, payment icons (e.g., Venmo, Square), sizing for social media, banners for EventBrite, etc. The <u>Magic Switch feature</u> enables resizing of an image for multiple purposes.

A statewide shared Canva Pro account will be in the budget for 2024-2025. Stay tuned for more details about how you can benefit from that shared account.

# "Open Up AAUW" Initiative Fails — Our Barrier Remains Firmly Standing In Our Own Way

As with almost anything, the failure of the 2024 "Open Up AAUW" initiative displayed "the good, the bad and the (really) ugly" of our situation.

The good news is that a record number of AAUW members across the country voted in this election – just over 37% of members in total and just over 46% of members in Washington State. A quorum was achieved quickly, and well over half – 65.1% -- of AAUW members voted in favor of dropping the college degree requirement. In Washington State, 4 out of 5 members voted affirmatively to "Open Up AAUW", ranking our state 8<sup>th</sup> in terms of positive support for the measure. Thank you to all members who took the time to vote and let their voices be heard!

The bad news is that the AAUW National bylaws require a 2/3 majority to pass any bylaws change -for the second time in 3 years, the "Open Up AAUW" initiative failed by a very small margin. In addition,
over 60% of AAUW members did not vote at all. AAUW membership has been declining for years.
Since the last "Open Up Vote", AAUW has lost 25% of its members, and a growing number of those are
honorary life members who no longer pay National dues. There are many reasons for the decline –
long-time members aging out, the tendency for younger generations not to be 'joiners' and, of course,
a global pandemic. For all of these reasons, AAUW's finances have been impacted. As always,
AAUW will continue to seek new members who support our mission, however our field of potential
members remains restricted by our college degree requirement. Not to mention that the outcome of the
recent vote does not demonstrate that we are "walking the talk" with respect to our stated value of
"inclusion."

The (really) ugly news is that the likelihood of AAUW receiving organizational / corporate grants – money that is vital to AAUW to continue to carrying out our mission – remains quite limited. Many organizations love our mission and the projects that we do, however, due to our degree requirement, we are viewed as an "exclusionary" organization and eliminated from consideration. While the majority of AAUW members voted to be more inclusive, the results of the vote telegraph to the outside world that AAUW has reaffirmed its commitment to exclusivity. Not a good sign.

As AAUW members, we're all proud of our degrees and the hard work that went into earning them. That is not to be diminished, nor are AAUW's many accomplishments over time. However, the heyday of most member organizations is in the past. If we are seriously committed to advancing gender equity for all women and girls through our AAUW work, we need to help our organization remain financially viable to do so. At this point, it's not known when the next opportunity will be to break down our barrier. Between now and then, please consider what we can do to prevent the previously unthinkable scenario of "three strikes and you're out."

#### NO on I-2117 Climate Commitment Act Repeal

NO means we support the effort to maintain the strongest policy in the country to reduce Greenhouse Gases (GHG), prevent catastrophic warming and protect our air and water quality. Funds from the carbon auctions support overburdened communities and seek environmental justice. Climate justice is a gender equity issue.

NO on I-2081 - AAUW-WA opposed I-2081 the "parental rights" initiative that was intentionally misleading and overreached existing state laws. ACLU, Legal Voices and QLaw filed a lawsuit to block the law from going into effect, but a superior court judge denied the emergency injunction. Th law went into effect June 6<sup>th</sup>. OSPI issues a statement on June 5: "Until additional clarity is provided on the areas where the initiative conflicts with existing state and federal law, school districts should not make changes to any policies and procedures that are implicated by the conflicting sets of law. When in doubt, school districts should follow federal privacy laws." AAUW-WA will continue to monitor OSPI guidance and the lawsuit(s). A bill is expected to be introduced in 2025 to amend the law.

Hello Everyone,

Thank you for your continued support of Tech Trek! Our team is very excited for what we've planned this year. We have several new and returning staff, as well as a mix of new and old activities that we think campers will love. Here are some camp updates:

**Camper Numbers:** Our last count showed that we had about 115 campers attending camp (July 14th - July 20th). To accommodate this, we have about 38 staff and two dorm buildings.

Visitor's Day: We are very pleased to be able to offer the opportunity for branch members to visit camp this year. Visitor's Day will be on Thursday, July 18th and will be from 8:30am to 2:30pm. This will allow branch members enough time to see Core Classes and afternoon labs. If you are interested in attending, please let your branch's Tech Trek Coordinator know so they can give me an attendance count. Please note that due to our large group this year, PLU will not be able to accommodate visitors at lunch. You are welcome to bring a lunch with you to eat on campus, or to meet up with other branch members at nearby restaurants. We have several recommendations that are excellent (campers usually eat lunch from about 11:45-12:45).

**Camper Packets:** The camper packets have all been mailed and are due to be postmarked back to our team no later than June 20th.

**Need for Staff:** Due to our large number of campers, we recently moved one of our Dorm Leaders to a second Health Aide position. For this reason, we have an opening for a Dorm Leader position and are looking to have it filled as soon as possible. If you know anyone who is interested, please let us know (they do not need to be an AAUW Member).

**Field Trips:** United States Geological Survey, Harbor Wild Watch, The Museum of Flight. Each camper will have the chance to attend two of the field trips listed above during camp.

#### Offered Classes:

Amazing Moons - Take a journey to our moon and discover how we see different phases as well as solar and lunar eclipses. Design experiments to learn how the crater patterns on the surface are formed. Go back in time to re-enact Galileo's groundbreaking telescopic observations of Jupiter's moons and learn his conclusions that affected the history of astronomy. Then take a grand tour of four of the largest moons of Jupiter to learn their amazing characteristics in order to create 3-D mission-directed settlements on each moon.

Bodies by Design - How do all the parts of our bodies work together to function as an amazing

biological whole? Join us while we explore the eleven human body systems! Through model-building, dissections, and use of microscopes, campers will: learn to identify the parts of each system; compare systems to each other at the cellular, tissue, and organ level; discuss each systems' function in relation to their structure; understand how the systems work together; and compare our body systems to those of other animals.

**Thinkabit<sup>fm</sup> Wearable Tech -**Are you interested in a career in technology? In Thinkabit<sup>fm</sup> Wearable Tech, you will explore how your unique talents might help you find the right career. In the Hands-on Engineering activities, you will learn about electronics and how to use them to complete circuits. Your final project will be a wearable project using what you learned about your unique talents in Hands-on Engineering,

**Marine/Environmental Biology** -Water, water, everywhere! In Puget Sound, we have a wealth of water and we'll be examining all of the forces that interact, as well as the creatures that inhabit water. We'll look at watersheds, estuaries and marine environments through several experiments, art projects and dissection. So, hold your nose and jump in for some science fun!

The Microscopic World -Embark on a journey into the unseen world with our Microscope Exploration Class! Check out the fascinating world of microscopic organisms and structures as you learn to wield the power of magnification. You will discover the hidden beauty of everyday objects, tiny insects, plant cells, and unlock the mysteries of the miniature universe. Through interactive classes you will develop essential microscopy skills, including slide preparation, focusing techniques, and specimen handling. Whether you're a curious beginner or a budding scientist, join us and uncover the wonders that lie beyond the naked eye in our Microscope Exploration Class.

**Fun with Physics** -What do hot air balloons, fish tanks, lava lamps, lanterns, earthquakes, thermometers, clouds and currents have in common? Motion through matter due to changes in energy. Your challenge will be to recreate an instrument that is capable of measuring changes of energy within a system. You will have the opportunity to dive deep into the concept of density and will surface with a greater understanding of how you experience this law of nature. We will definitely have fun with Physics!

**Environmental Detectives -** Solve the mystery of the big fish die-off in Gray Bay! The big fish die-off happened around five years ago, and Gray Bay City Council determined that the culprit was a water slide that had been put in five years ago. A student at a nearby school took out their chemistry kit and decided to test the water. They discovered that there was no chlorine in the water near the water slide and that the City Council must be wrong. Thus, a search for the cause of the big fish die-off begins! Suspects include toy factories, a golf course, a cattle ranch, and more. You will perform chemical and biological tests to discover who harmed Gray Bay.

Remembrances of Ann Copeland

(November 1939-May 2024)

Anne Copeland was a longtime member of Tacoma Branch. We remember her fondly.

**Inclusive**—that was Ann's intent and practice. She made a point to get to know new members, invite them to her house and give them a job, such as to copy, fold, stamp and mail the newsletter or help with a project. She had a gift for creating a truly welcoming environment where everyone felt comfortable and connected. She hosted a Halloween party where we all came in costumes and silent auctions; these were a lot of fun. With these activities, we became real members of Tacoma AAUW.

**Persuasive and Creative**—these were qualities Ann brought to her fundraising goals for AAUW. Whether it was inviting everyone to her backyard for a salmon feast or auctioning off one of her bracelets at the end of a branch meeting, she got the job done. In fact, under her leadership, Tacoma AAUW completed donations for a \$100,000 endowment in honor of the branch 2007 Centennial, which continues to fund women scholars in our state.

Joy and Purpose--Ann Copeland was a woman who radiated light and warmth. Her passion for AAUW was contagious, and she had a knack for bringing people together around a cause. She was a magnet for conversation, and wherever she went, laughter and lively chatter followed. Even if you found yourself momentarily isolated, Ann would invariably seek you out, checking in with a friendly smile and, more often than not, a playful request for a small AAUW donation! Her monthly movie nights were a joy. Her home became a haven of laughter, filled with delicious popcorn (with butter) snacks, captivating films, and stimulating conversations.

**Supportive and Giving--**We remember how helpful she was to our member Roberta Combs when she had to find assisted living and get her house ready to sell. Ann got a team of AAUW members together to clean the house and organize a house sale which was quite a chore. It was amazing how much work Ann did to accomplish this. She also found a place for Roberta to live which was just down the street so she could enjoy the same view that she just used to at her own house.

**Selfless and Generous--**One of the most vivid memories of Ann is from an AAUW Tacoma branch meeting at the Wheeler branch of the Tacoma Public Library. After the presentation, during branch announcements, Ann stood up and, with a determined glint in her eye, announced she was collecting donations for a specific fund in the name of her husband, Jimmy, who had sadly passed away that very morning. This act of selfless generosity, even amidst her own grief, perfectly encapsulates the essence of Ann Copeland: a woman who brought joy and purpose to everyone she encountered.

We were sorry when she moved to Portland for her retirement, and though we think she was happy there, we do miss her.

Climate Change - Washington State and Beyond:
