Last week, on a lovely fall day, we wanted to get up to the high country on Mt Rainier. On the way we stopped at Federation Forest and walked the nature trail. I was curious about the history of this park especially since women of the Washington State Federation of Women's Clubs founded it. I wondered if AAUW had any association with this group.



The Federation Women's Clubs was founded in 1890, by Jane Cunningham Croly, a journalist. The founding of the federation was really a reaction to her exclusion from an allmale press club honoring Charles Dickens. So, she founded Sorosis for professional women and suggested that this club be a model for women's' clubs across the country. (I know about Sorosis because my mother was invited to become a member of the Spokane Sorosis!) Now known as the General Federation of Women's Club (GFWC), it also has a national office in Washington D.C. and appears to be like AAUW. The mission statement says that it is a service organization that promotes education, supports the arts, preserves natural resources, encourages healthy lifestyles, stresses civic involvement, and works toward world peace and understanding."

Now, the connection to Federation Forest State Park. Our state clubs were established in1896, and among other things were concerned about deforestation and the loss of old growth forests. The minutes from a meeting in 1898 reflect that importance; one of the founders pleaded "for the preservation of forests because they purify the air and water, modify climate, prevent freshets and keep up supplies for springs". These ideas certainly are being said today as we consider the initiative on climate change.

The first park, established in 1928, was on Snoqualmie Pass and called Big Tree. Over the years there were "fire, floods and the ax," so they began looking for a new space. They raised money to buy the White River Logging Company section of old growth timber along the White River. In 1949 with the cooperation of the state legislature, it was dedicated as a state park with over six hundred acres. In 1958 Catherine Montgomery left money in her will to build the interpretive center. An early president, Elizabeth Maltby designed the nature trails. Talk about legacy! Area clubs still have service days at the park, and I suspect that they may be the ones who make all the new little signs for the natural vegetation.

On further reconnoitering on the web, Washington State has sixteen clubs in such places as Waterville, Moses Lake, Commencement Bay, Kitsap, and Kirkland within five districts: Columbia, Peninsula, King County, Northeastern, and North Central. Currently, there are 60,000 members in fifty states including over a dozen countries. In their hay day 1955, there were as many as 850,000 members in16,000 clubs in the US! The decline in memberships occurred as "middle class women moved into the public mainstream" which I take to mean that women entered the workforce. GWFC continues to have national conventions, 2024 was in Chicago and 2025 it will be in Atlanta. Like us, members are now older. However, unlike us, they do have junior clubs for young women and girls. Something to think about! So, I found no explicit relationship with AAUW, however this fall experience was very inspiring, and no one suspects what a walk in the woods will turn up!

#### **Unscrambling the Alphabet Soup**

IRS, SOS, BOIR – What Is My Branch Required to File? by Barbara Sando, Bylaws Chair – <u>bylaws@aauw-wa.org</u>

Each AAUW affiliate is a separate legal and financial entity – and therefore responsible to file various forms and reports on an annual or as-required basis.

**IRS – Internal Revenue Service**. AAUW affiliates are tax-exempt under Internal Revenue Code Section 501(c)(4) – a social welfare organization – or under Section 501(c)(3) –a charitable organization. [Your IRS Determination Letter documents your status. If you don't have a copy of your letter, you should request a copy from the IRS.] While it may sound counterintuitive, tax-exempt organizations are still required to file an annual income tax return with the IRS. Since AAUW's fiscal year runs from July 1 through June 30, Form 990 income tax returns are required to be filed by November 15.


AAUW National does a great job of reminding affiliates of their IRS income tax return filing requirements, and offers those who have less than \$50K in revenue the option to be included in National's filing. (For revenue greater than \$50K, branches must file themselves and determine which Form 990 is applicable based on revenue and gross assets).

What AAUW National doesn't do is train affiliates on other IRS rules and regulations that may apply to them. One key IRS rule to be aware of is that businesses are required to file a Form 1099-NEC to any individual or LLC – i.e., any non-corporation – that they

pay \$600 or more to in a calendar year, regardless of whether the money may be taxable or non-taxable to the recipient. Such payments could be for almost anything – an honorarium, monies to cover various expenses for an individual, payment for services, etc. [Businesses are also required to file a Form 1099-NEC for any legal services they pay, unless the law firm is a corporation.] It is then the recipient's responsibility to declare all income they've received, taxable or non-taxable, even if it's less than \$600 from an entity, on their individual or LLC tax return each year. Forms 1099-NEC must be issued by January 31st for the prior calendar year.

**SOS – Secretary of State.** If your affiliate is incorporated as a non-profit corporation in the State of Washington, you are required to file an Annual Report and pay an annual registration fee. These are due on the anniversary of the date your affiliate was incorporated. Once you receive notice, you can file and pay online at <u>Corporations and</u> <u>Charities System (wa.gov)</u>.

**BOIR– Beneficial Ownership Information Report**. When incorporated affiliates receive their Annual Report Due Date Notice this year, it will include a note saying, "File a Beneficial Ownership Information Report with the U.S. Treasury's Financial Crimes Enforcement Network (FinCEN)." This is a new requirement under the Corporate Transparency Act, designed to increase transparency in business ownership and help combat financial crimes. The good news is that, since we are tax-exempt entities and have no owners, AAUW Affiliates do NOT need to file a BOIR. See more information at <a href="https://boir.com/">https://boir.com/</a>.



#### **CELEBRATING A CENTENNIAL GENERATES EXCITEMENT**

There's been a lot of excitement generated in our Olympia Branch since we discovered that we will celebrate our 100th Anniversary in January, 2025. We were aware that our efforts began in January, 1925, but were unable to determine on which day until two of our members, Jane Owens and Vicki Merkel, decided to visit the archives at WWU in Bellingham to see if they could discover the exact date. Sure enough, they uncovered a document that mentioned January 18, 1925. Our first President was Elgia Wittwer Dawley, who served until 1926.

#### HOW BEST TO CELEBRATE THIS ACHIEVEMENT?

The big question we've been asking ourselves is how we should celebrate this awesome achievement in our branch? After much discussion we came to the conclusion that it might be more fun to celebrate some aspect of entering the "100-Year-Club" every month. Since our branch is organized around a Leadership Team model, our LT decided to hold several themed programs throughout 2025. What they will be hasn't exactly been defined yet. But we're off to an enthusiastic start.

#### SHOW & TELL ACQUAINTS US WITH PAST EVENTS

On September 17, our Leadership Team (Jane Owens, Jeanette Lomax, and Joan Mikow) hosted a show-and-tell of some of the "oldest" items we had in our possession. That

included a collection of all of the convention bags that Jeanette had accumulated in her long tenure as member of the Olympia Branch. Several posters that celebrated Gladys Burns' achievements, some old newsletters which dated back to the 1970s, 80s and 90s, and several hand-written communications — all written in a beautiful cursive. We enjoyed one letter from a past historian, who had failed to send her report in on time. Her excuse was that she had been to too many Husky games and hadn't had time to get her report ready. She apologized for being late and figured she'd probably get "fired" from her job!

#### PAST STATE PRESIDENT ADDRESSES CONVENTION IN 2002

Notes from a talk that Winnie Olsen, who was state president from 1952-54, held on January 15, for the 2002 State Convention describe holding teas for senior girls and their mothers with a college representative as guest speaker. In the 1940s, 50s and 60s there was a sponsorship of a weekly legislative forum during each legislative session, where top legislative leaders, state officials, and lobbyists headlined the morning discussions. From those programs, "the spark was lit for the formation of the Olympia League of Women Voters. AAUW members were among its first leaders and the two groups continue to cooperate with candidate forums and Women's Lobby Day."
